Project Description:	Energy Efficiency in Public Buildings (EEPB) Programme promoted by the Government of the Republic of Serbia and supported by KfW includes energy efficiency improvements in 20 (+) educational facilities in Serbia EEPB is a continuation of previously completed SEEP1 and SEEP2 projects. The Programme is divided into two stages; first stage (Phase 1) includes 18 schools which remained from previously implemented SEEP2 project sponsored by the World Bank, and Student Dormitory "Karaburma" Belgrade, while second stage (Phase 2) shall include shortlisted schools selected from so called Long-List provided by MoESTD. Main objectives of the Programme are: (a) Energy savings and reduced greenhouse gasses emissions achieved by increase in energy efficiency of buildings and energy consumption reduction. (b) Increase in sustainability of existing structures. (c) Overall teaching and learning environment improvement.
	The EEPB Programme is expected to last approximately 38 months approved works relating to so called "Fast Track Schools" (FTS) should be completed during spring of 2016.
